INFORMATION TEXT ON THE COLLECTION AND PROCESSING OF PERSONAL DATA

In accordance with Law No. 6698 on the Protection of Personal Data ("Law") and relevant legislation, your personal data may be processed by ONCOROAD HEALTH AND CONSULTANCY SERVICES LIMITED COMPANY ("OncoRoad") as the Data Controller under the framework explained below and in compliance with other legal regulations.

- 1. Collection, Processing, and Purposes of Processing Personal Data Your personal data may be collected for the purpose of carrying out the appointment services provided by OncoRoad, as well as for the planning and management of its financing. It may be processed to the extent necessary for OncoRoad's activities and through verbal, written, visual, or electronic means, such as call centers, websites, and other similar channels. Your personal data may be processed by OncoRoad within the scope and for the purposes specified in this article, including but not limited to the following:
 - **Identity Information**: Your name, surname, identification number, place, and date of birth, gender, and other identity information that can identify you.
 - **Contact Information**: Your phone number, email address, and other contact details, as well as the voice recordings kept by customer representatives or patient services in accordance with call center standards, and any personal data obtained when you contact us through email, mail, or other means.
 - **Financial Information**: Your bank account number, IBAN number, credit card information, billing details, and other financial information.
 - **Health Information**: Diagnosis or medical information you specify when requesting an appointment, any health data, or personal information you submit or enter on the www.oncoroad.com website.

The personal data collected by OncoRoad (including special categories of personal data but not limited to) may be processed for the following purposes:

- Verifying your identity,
- Protecting public health, providing preventive medicine, medical diagnosis, treatment, and care services, and planning and managing health services and their financing,
- Sharing information with the Ministry of Health and other public institutions and organizations as required by relevant legislation,
- Planning and managing the company's internal operations and daily activities,
- Measuring, increasing, and researching customer satisfaction regarding services,
- Notifying you about your appointment,
- Conducting risk management and quality improvement activities,
- Complying with legal and regulatory requirements,
- Issuing invoices for the services rendered by our finance and marketing departments,
- Sending reminders, notifications about appointments, and providing information related to the delivery of services,
- Providing information about campaigns and facilitating participation through the marketing, media, and communication departments, as well as designing and delivering special content and benefits through web and mobile channels.

The personal data collected may be stored in physical archives and/or IT systems of OncoRoad in both digital and physical formats.

- **2. Transfer of Personal Data** Your personal data may be shared by OncoRoad with its partners, institutions, and companies involved in collaboration, the Ministry of Health and its affiliates, law enforcement agencies, courts, and all judicial authorities, third parties, your authorized representatives, lawyers, tax and financial advisors, auditors, third-party consultants, regulatory and supervisory authorities, and other public entities for the purposes stated above.
- **3.** Methods and Legal Grounds for Collecting Personal Data Your personal data is collected and processed for the purposes mentioned above and for OncoRoad to conduct its business activities in accordance with the law. The legal grounds for collecting your personal data include:
 - Law No. 6698 on the Protection of Personal Data,
 - The Basic Law on Health Services No. 3359,
 - Decree-Law No. 663 on the Organization and Duties of the Ministry of Health and its Affiliated Institutions.
 - Regulations on the Processing and Protection of the Privacy of Personal Health Data,
 - The regulations of the Ministry of Health and other relevant legal provisions.

Your personal data will be processed under Article 5/2(b) of the Law on the basis of "explicitly stipulated by law," as well as Article 5/2(c) for the purpose of "processing personal data necessary for the establishment or performance of a contract," Article 5/2(e) for "establishing, exercising, or protecting a legal right," and Article 5/2(f) for "legitimate interests of the data controller."

Your health data will be processed under Article 6/3(d) for "the establishment, exercise, or protection of a legal right" and Article 6/3(e) for "ensuring the necessary activities are carried out by persons or authorized institutions bound by confidentiality for the protection of public health, preventive medicine, medical diagnosis, treatment, and care services."

- **4. Your Rights Regarding the Protection of Personal Data** According to the Law and the relevant legislation, you have the right to:
 - Learn whether your personal data is processed,
 - Request information if your personal data has been processed,
 - Access your personal health data and request a copy of it,
 - Learn the purpose of processing and whether it is used in accordance with its purpose,
 - Know the third parties your data is shared with, domestically or internationally,
 - Request correction if your data is incomplete or incorrect,
 - Request the deletion or destruction of your data,
 - Request that third parties to whom your data is transferred be informed about corrections or deletions,
 - Object to any outcomes against you from processing your data exclusively through automated systems.

If you exercise any of these rights, the related information will be provided to you in writing or electronically through the contact information you provide.

5. Data Security OncoRoad protects your personal data by taking all necessary technical and administrative security measures in accordance with information security standards and procedures. These security measures are provided at an appropriate level in line with potential risks, considering the technological possibilities.

- **6. Complaints and Communication** Your personal data is carefully protected within the scope of technical and administrative capabilities, and necessary security measures are ensured at an appropriate level. You can submit your requests regarding your rights under the Law by completing the "Personal Data Protection Law Application Form" available at www.oncoroad.com. You can submit the form by:
